## **NORTHOP COMMUNITY COUNCIL**

Minutes of the meeting of Northop Community Council held at the Memorial Institute, Northop on Monday 13<sup>th</sup> June, 2016.

**PRESENT:** Councillors Geoff Pierce (Chairman), Chris Ruddle (Vice-Chairman), Haydn Bateman, Marion Bateman, John Carlin, Linda Deane, Pauline Lawton-Hughes, Rob Mackey (until the conclusion of Item 7), John Roberts and the Clerk. Mrs. Jan Blackwell and Mr. Roy Pierce gave the presentation. PCSO Amy Hughes was present until the conclusion of agenda item 2.

**APOLOGIES** – Received from Councillors Joanne Millar, Alan Watkin and Jos Wynn-Williams.

PRESENTATION ON THE PROPOSED PROVISION OF A COMMUNITY DEFIBRILLATOR by Mrs. Jan Blackwell and Mr. Roy Pierce of Northop Cricket Club.

Mrs Blackwell advised that Northop Cricket Club had chosen to support the British Heart Foundation and had organised a Snowdon Bike Ride on 25<sup>th</sup> June to raise money for the charity. The increased number of instances of cardiac arrest in young people had influenced the Club's decision to seek to purchase a defibrillator. The Club have been advised that there is no funding available from Welsh Hearts nor from the Welsh Ambulance Service. The cost of a defibrillator is approximately £1,200 and if the equipment is to be made available to the community, it would need to be housed and powered in an external cabinet. The cost of the powered cabinet would be approximately £500. The Club had approached the Council on this matter with a view to exploring the option of providing a shared community defibrillator.

Members posed a series of questions regarding the above and Mrs. Blackwell and Mr. Pierce responded as follows:

- The Welsh Ambulance Service will provide free training for volunteers to use the defibrillator but clarification would be sought for on-going/refresher training.
- The defibrillator is fully computerised and would be of particular benefit for use on young victims of cardiac arrest. Paramedics advised that First Aiders are not robust enough in CPR on young victims.
- Mrs. Blackwell would clarify security arrangements/locking mechanism for the external cabinet.
- Publicising the availability of a defibrillator would be considered and would need the support of the village.

Cllr. M. Bateman advised that Mold Town Council was aiming to raise £25,000 for the Mayor's Charity to provide defibrillators in the area. Furthermore the Mayor of Mold had agreed that Northop Community could purchase a defibrillator under the same discount scheme as the Town Council.

It was agreed that the Clerk should contact Mold Town Council to explore the option of costings for defibrillator and external cabinet provision at Sychdyn and Northop.

## 1. DECLARATIONS OF INTEREST

No Declarations of Interest were made.

#### 2. POLICE MATTERS

PCSO Hughes provided the members with an update on Police Matters in the community and reported no incidents in Northop but a theft of a vehicle in Sychdyn in early May.

The Council was advised of a review of PCSO allocation in South Flintshire, effective from 13<sup>th</sup> June. The review formed three new geographic Safer Neighbourhood Groups and some vacancies (to be filled) were identified.

The design of the Chair reflected the local area and featured silver to represent the former silver mines of Halkyn and Oakenholt. Cllr. Deane thanked the Council for the opportunity to attend.

## **13. GULLIES** (Cllr. J. Carlin)

Cllr. Carlin reported that drainage gullies between the driveway to Lower Soughton Hall and Sychdyn were blocked. Concerns were raised regarding the ability of FCC to clear and maintain all gullies and to respond to the increasing incidents of flash-flooding in the county. The Clerk to write to the Head of Streetscene and Neil Hickie expressing concern and asking that the blocked gullies be cleared. Cllr. M. Bateman to request a schedule of gully cleaning for the community area.

It was resolved that gully issues would be reported in future under the standard agenda item 4 (currently Street Lighting).

## **14. SYCHDYN FOOTBALL CLUB** (Cllr. J. Roberts)

Cllr. Roberts reported that Sychdyn Football Club had had a very successful year but had not been promoted to the higher league. The Council to send a letter of support to the Club, congratulating them on their success. Cllr. Roberts to provide the Clerk with further information.
